Over the past 12 years, she has collaborated with ACLM Past President Dr. Sandy Sanbar in co-chairing the ACLM/ABLM's "A Day with the Judges" conferences, focusing on pertinent legal medicine issues that have attracted thousands of participants.

In her response, Justice Gurich expressed profound enthusiasm and gratitude for the recognition bestowed upon her by the College. We look forward to <u>Justice Gurich</u> accepting this prestigious honor in Houston during ACLM's 2025 65<sup>th</sup> Annual Conference.

## ACLM AMA Resolution - H.R. 7225, the bipartisan, Administrative Law Judges Competitive Service Restoration Act

ACLM, through Past President and <u>AMA</u> Delegate Richard Wilbur, MD, JD, FCLM, and AMA Alternate Delegate <u>Rey Gonzalez, Jr.</u>, MD, JD, FCLM, and with the initiative and efforts of <u>David Mullens</u>, DPM, JD, FCLM, is continuing to advocate for AMA to support <u>H.R. 7225</u>, the bipartisan, Administrative Law Judges Competitive Service Restoration Act. This bipartisan Act was introduced on February 4, 2024, by Congressman Gerry Connolly (D-VA-11) and is co-sponsored by Congressman Brian Fitzpatrick (R-PA-1) and Congressman Michael Lawler (R-NY-17) and is endorsed by the American College of Legal Medicine, the Association of Administrative Law Judges, and the International Federation of Professional and Technical Engineers.

### AMA Scope Creep Advocacy Efforts

As the medical society at the interface of law and medicine, the issue of scope creep falls within the domain of legal medicine and carries significant implications for healthcare practice. Given the importance of the issue and the potential impact on healthcare professionals and patients, I have asked the ACLM's Ethics Committee, chaired by distinguished BOG member <u>Michael Brooks</u>, MD, JD, FCLM, to thoroughly discuss the implications, potential benefits, and any concerns associated with ACLM's endorsement of AMA scope creep advocacy efforts. Dr. Brooks is a neuroradiologist and an attorney, and he teaches medical topics and ethics to attorneys.

The Ethics Committee will assess whether ACLM's involvement aligns with its mission, values, and objectives. Considerations may include how the proposed scope of practice laws align with ethical principles, patient safety, quality of care, and the professional autonomy of healthcare practitioners.

### American Academy of Pediatrics - Letter to ACLM Regarding Gun Violence

On March 26, 2024, the American Academy of Pediatrics (AAP) invited ACLM to join them and other organizations in a letter to Congress supporting CDC/NIH funding for gun violence prevention research for FY25. The devastating impact of firearm-related violence, including suicides, violent crimes, and accidental shootings, affects individuals, families, and communities nationwide. While the effects of gun violence are abhorrent, this letter did not secure the required number of votes from the Board of Governors for approval. Concerns were raised about the need to find meaningful changes from the first four rounds of yearly funding. There's also a call for local public health departments to take a more active role in mitigating gun violence. I conveyed to AAP an eagerness for more opportunities for ACLM to collaborate with AAP and other medical societies to make a comprehensive and significant scholarly contribution on this issue. In response, AAP extended an invitation to ACLM to join them and the American College of Emergency Physicians in the Gun Violence Prevention Research Roundtable.

### 8th Edition Legal Medicine Textbook

Past President Sandy Sanbar, MD, PhD, JD, FCLM, DABLM and I are working with our publisher Elsevier to complete the final touches of the upcoming 8th Edition of the preeminent textbook *Legal Medicine*. Authored by ACLM and the American Board of Legal Medicine, this premier treatise in legal medicine has 82 chapters in legal medicine, health care law, and medical ethics. It is now available for pre-order through the ACLM website.

On behalf of the College, I extend our heartfelt thanks to Dr. Sanbar for his unparalleled dedication as the Editor of all editions of this preeminent book. His tireless work has played a pivotal role in shaping and maintaining the high standards of this invaluable resource.

## The Journal of Legal Medicine

In 2023, JLM had more than 17,000 downloads and had generated income for the College. I would like to thank Past President Joe Piorkowski, Jr., DO, JD, MPH, FCLM and distinguished BOG member <u>Amir Pasha</u>, DO, JD, FACP, FCLM, who served as Editors-in-Chief in the recent edition.
