Special thanks go to Dave Mullens, DPM, JD, FCLM, whose admirable initiative to advocate for this issue began this process, highlighted by his presentation at the ACLM 2023 Annual Conference in Orlando, Florida. Additionally, thank you to Peter Rheinstein, MD, JD, MS, FCLM, for his support and updates on this issue. Dr. Rheinstein is the Chairman of the American Board of Legal Medicine and the Chair of the AMA Reference Committee B (Legislation).

We have more work to do to advocate for this initiative, including our continued collaboration with Congressman Gerry Connolly (D-VA) and Congressman Brian Fitzpatrick (R-PA). However, for now I want to congratulate everyone who helped make this milestone happen.
